



The advantages at a glance

The second generation of our popular conventionally ligatable classic product has a new design optimisation that is so close to the pulse of modern orthodontics, that it leaves little to be desired. Practitioners as well as patients will benefit from a bracket that meets the highest expectations and creates enthusiasm for its easy wear and handling.



Effective orthodontics begins with bracket handling

For the practitioner there are several new advantageous features. The Mini Sprint® II was outfitted with FORESTADENT's anatomically curved hook base. This fits even better to the natural tooth contours and allows optimal adhesion due to the integrated hook style-base.

The newly integrated, continuous midline mark serves as an orientation and insertion guide and the circumferential edge of the pads ensure for better positioning and bonding behavior of the brackets.

At the end of the treatment, mesial and distal bevels on the pad rim ensure that the debonding pliers can securely grip the bracket and enable an easy removal of the appliance treatment apparatus.

Comfortable companion on a daily basis

People who wear brackets should barely notice them. To make this happen, we have created a flattened Mini Sprint® with labial surfaces that are even more rounded. Even the design of the hooks that are used for the optional use of elastics, were lowered in the second generation of this bracket and created in a more even and less perceptible manner.

The optimised polishing techniques have created surfaces that are even smoother. This increases the patient comfort and prevents accumulation of plaque and irritations of the mucous membranes.



The FACE Evolution II prescription

Naturally beautiful and stable results

The team of internationally renowned orthodontists advocate a treatment approach that includes harmonising the facial and dental aesthetics in addition to optimising occlusal function. Beyond this it includes periodontal health, an orthopedically stable temporomandibular joint position, open airways and stable results.

The FACE group, which has created an update to the Roth philosophy with its FACE Evolution Prescription, has extensive experience. FACE Evolution II is now the latest version of this treatment approach. It is characterized by modified torque values of the brackets for upper and lower cuspids and premolars and also the torque of the first and second upper molars. In this way the upper fours and fives were changed from -7° to 0° and the lower premolars were changed from -17° to -12° (1st premolar) and from -22° to -17° (2nd premolar). The basis for these modifications was born from the conclusive information obtained through CBCT-scans in individuals before and after treatment. These suggested the modification of torque values in order to position the roots securely in the alveolar bone and thus avoid dehiscences and/or fenestrations and to provide stability and periodontal health. Since the roots are in their natural position in the periodontium, this leads to not only more stable, but also more aesthetic results.

The background for this adjustment is the desire to implement an anatomically optimal tooth position while also achieving a more attractive smile.


